

WAIVER AND TERMS AND CONDITIONS

Code of Conduct: Our number one rule is simple: Don't be a jerk. This league is all about playing the game you love (or are just getting to know), meeting new people, and having some fun. So we ask that you refrain from things like verbal and physical abuse of teammates, opponents or referees (including but not limited to fighting, intentional fouls, excessive profanity, etc.) and excessive drug and alcohol use before and during games. We give our referees broad latitude to remove you from a contest, either partially or completely, and if such things are warranted may also ask that you not return either for that season, or any and all future seasons.

Terms and Conditions

RISK FACTORS: The undersigned understands and acknowledges that the use of equipment, facilities and services provided by Grand Traverse Social Sports, LLC involves risks such as, but not limited to, personally bodily injury, which might result from the use of equipment or facilities, from the activity itself, from the acts of others, or from the unavailability of emergency or emergency medical care. RISK OF PROPERTY DAMAGE, BODILY INJURY, AND POSSIBLE DEATH.

ASSUMPTION OF RISK. The undersigned ASSUMES ALL RISKS THAT ARISE OUT OF THE USE OF THE EQUIPMENT OR FACILITIES, THE ACTIVITY ITSELF, THE ACT OF OTHERS, OR THE UNAVAILABILITY OF EMERGENCY CARE, including but not limited to, those RISK FACTORS described in section 1 above.

ACKNOWLEDGMENT OF POLICIES AND PROCEDURES. The undersigned acknowledges reading and knowing all of the policies and procedures relating to the activities, facilities, and/or equipment and understands that the safe and proper use of the facilities, equipment or participation in the activity is dependent upon carefully following such policies and procedures.

PREREQUISITE SKILLS AND TRAINING. The undersigned acknowledges that he or she has the requisite skills, qualifications, physical abilities, and training necessary for proper and safe use of the equipment and facilities and to participate in the activity itself. The undersigned agrees that if he or she has any questions as to what skills, qualifications or training is necessary to properly use the equipment, facility, or to participate in the activity itself, then they shall direct such questions to the appropriate staff member on site.

RELEASE. The undersigned RELEASES Grand Traverse Social Sports, LLC, its organizations, the officers, employees and agents of each and agrees NOT TO SUE them on account of or in conjunction with any claims, causes of action, injuries, damage, cost of expenses arising out of the activity, including those based on death, bodily injury or property damage whether or not caused by the acts, omissions or other fault of the parties being released.

WAIVER. The undersigned waives the protection afforded by any statute or law in any jurisdiction including those in the area of MI or otherwise areas in which Grand Traverse Social Sports, LLC, operates and whose purpose, substance, and/or effect is to provide that a general release shall not extend to claims, material or otherwise which the person giving the release does not know of or suspect at the time of executing the release. This means, in part, that the undersigned is releasing unknown future claims.

INDEMNIFY AND DEFEND. The undersigned agrees to INDEMNIFY AND DEFEND Grand Traverse Social Sports, LLC and its officers, employees and agents (hereinafter jointly referred to as "indemnitee") of each against, and hold them harmless from any or all claims, causes of action, damage judgments, costs or expenses, including attorney fees which in any way arise from the activity or this agreement which include but are not limited to damages to or destruction of any property of the indemnitee, of any others, injury or death of the undersigned or anyone else or

any liability arising from the act or negligent act of the indemnitee, the undersigned or anyone else.

PAY. The undersigned agrees to pay for any or all damages to any property or indemnitee caused by the undersigned either negligently, willfully, or otherwise.

REPRESENTATIVES. The undersigned enters into this agreement for himself/herself, his/her heirs, assigns and legal representatives.

EMERGENCY TREATMENT CONSENT. The undersigned, as a participant in the subject activity, hereby consents to medical treatment in a medical emergency where the undersigned is unable to consent to such treatment.

INSURANCE. The undersigned understands that Grand Traverse Social Sports, LLC does not offer participant insurance. The undersigned is encouraged to have a physical examination and to purchase health insurance prior to any and all participation.

RELEASE FOR USE OF LIKENESS. Effective as of the date of player registration, approval for past use and permission for present and future use is being granted to Grand Traverse Social Sports, LLC, to use a photo, video or other image of registering league or event participant. Permission is being given by the registering and undersigned league participant as the photographed party. The undersigned is an adult and fully authorized to sign this consent and release. The Likeness of the photographed party may be used and/or published individually or in conjunction with other photography or video works and in any medium (including without limitation, print publications, online promotional materials) and for any lawful purpose including without limitation, trade, exhibition, illustration, promotion, publicity, advertising, and electronic publication.

ACKNOWLEDGMENT. The undersigned has read and understands this agreement and realizes it relates to surrendering valuable legal rights and does so freely and voluntarily.
